The Presidency has made a special employment stimulus programme available to the Sports sector to disburse via The Sports Trust. The Presidential Employment Stimulus Programme (PESP) is geared towards **employment creation and retention initiatives** aimed at sporting persons within the sector. The Presidential Employment Stimulus Programme is a five-month injection and has to be concluded by 31 March 2021.

How is The Sports Trust disbursing the PESP?

The Sports Trust is disbursing funding by focusing **on the retention of Staff Subsidy as employed by the Sporting** Federations/Bodies/Members of SSCN/Gym and Fitness Centres. All applications must be channelled through the respective Sports and Recreation Bodies (affiliated to SASCOC, Boxing SA and SAIDS, Members of SSCN, including Gym and Fitness Centres).

Closing date: Extended to 20 November 2020

Applications to be submitted to the Sporting Federation/Body/Members of SSCN/Gym and Fitness Centres and in compliance with the criteria and requirements as outlined in the Annexure. The Sports Trust is also responsible for the review of applications by means of the adjudication panel which is in place for adjudication.

FREQUENTLY ASKED QUESTIONS

- Who may apply?
Employers who seeks to retain their staff members during this period. Only South African citizens with a valid South African ID may apply.
- Can an applicant apply more than once?
No. An applicant can apply only once.
- Do funds have to be spent by 31 March 2021?
Yes.
- Can funds be disbursed after 31 March 2021?
No.
- Can an application be considered after the deadline?
No, all applications have to be submitted within the allocated period.
- Can individuals submit their forms personally or electronically to The Sports Trust?
No, all application forms must be submitted to the Sports Federations (all affiliated to SASCOC); DSAC Sport Entities (Boxing and SAIDS); Recreation Bodies (Members of SSCN); Gym and Fitness Centres
- Can my application be submitted without all the supporting documents?
No, an application form without supporting documents shall result in immediate disqualification.
- I have a sports qualification and I am currently unemployed, can I apply?
No, this is not a new job opportunity but to retain existing jobs.

- e) Incomplete forms shall result in immediate disqualification.
- f) Provision of false information will be treated as fraud and dealt with through appropriate Criminal Justice System.

- b) A list of relevant employees is required (Name and Surname, ID Number, Race, Gender, Home Address, Contact Number and Employee position in the National Federation/Sports Body/SSCN Member/ Gym or Fitness Centre).
- c) Applicant's complete application form
- d) **A contract of appointment and /or election report is compulsory**
- e) Copy of South African ID per employee
- f) CV of each employee
- g) Proof of Bank details of each employee
- h) Tax Number for each employee
- i) National Federations/Sports Bodies/SSCN Member/Gym or Fitness Centre - Banking details
